Proposed rule amendment

Proposal a special resolution to amend cooperative rule 114 related to *Determination of Dividend*.

From:

DETERMINATION OF DIVIDEND

- 114. Any dividends declared will be allocated in accordance to the following rules:
- (a) Dividends shall be distributed according to the number of shares held by a member.
- (b) The dividend distributed shall be calculated on the daily share holdings of each member.
- (c) Partial shares will also be counted towards a member's allocation of dividend.

To:

DETERMINATION OF DIVIDEND

- 114. Any dividends declared will be allocated in accordance to the following rules:
- (a) Dividends shall be distributed according to the number of shares held by a member.
- (b) The dividend distributed shall be calculated on the daily share holdings of each member.
- (c) Partial shares will also be counted towards a member's allocation of dividend.
- (d) A member will not be eligible to receive such dividend or any other distribution unless they retain their membership up until the date of dividend declaration.

Reason for amendment

Members who cancel their memberships with ICFAL express a desire to disassociate from the cooperative completely. Currently, small amounts of dividends continue to accrue to closed accounts, leading to accounting complexities and administrative challenges. To enhance accounting recognition and streamline the dividend accrual process, we propose implementing measures to address these minor dividend accruals in closed accounts.

Effect of rule amendment

Members who cancel their ICFAL membership with ICFAL will no longer be entitled to dividends unless they retain their membership up until the dividend declaration date. This will improve our dividend provision process and remove unnecessary liabilities from ICFAL's accounts.
